In making this Self-Exclusion Notice, I acknowledge and accept the following:

1. I agree not to seek entry to or attempt to enter the Nominated Sites or make or attempt to make a telephone wager at any time in the future. This exclusion will commence upon receipt of this signed Self Exclusion Notice by **Sportsbet Pty Ltd** during normal business hours or the next business day if received outside of business hours. The signed notice should be faxed or emailed per the contact details below.
2. I understand that the Sports Bookmakers may remove my access from, or prevent me from entering, the relevant Nominated Sites and I authorise the Sports Bookmakers to prevent me from entering or to remove my access from the relevant Nominated Sites.
3. I understand that my personal details and the details of the exclusion will be placed on the Responsible Gambling Incident Register held by the Sports Bookmakers.
4. I acknowledge that the accounts held with the nominated Sports Bookmakers have been permanently suspended upon my initial notification. I understand that the Sports Bookmakers will not allow me or anyone else to use any account I have with the Sports Bookmakers in the future and I authorise the Sports Bookmakers to close any current account upon receipt of this signed notice to Sportsbet Pty Ltd (after settlement of any outstanding bets).
5. I understand that my exclusion from the Nominated Sites and telephone wagering is voluntary and does not place any obligation, duty or responsibility on any other person or body other than me and I further understand that this Notice is not a contract and it in no way binds the Sports Bookmakers, save to the extent required by law.
6. I agree to release, and covenant not to sue the Sports Bookmakers or their servants, agents or contractors ("the released persons") from all actions, suits, claims, demands whatsoever, which but for this Notice, I could now or hereafter assert, bring or make, or by anyone on my behalf, arising from any damage or injury or otherwise caused directly or indirectly as a result of any act, default, or omission of the released persons in relation to the matters contained in this Notice.
7. I acknowledge that I had the right to seek independent legal or other professional advice before signing.
